



Airport Sydney International Inn Car parking Terms & Conditions

1. The following conditions apply when you enter, leave or use this car park.
2. You enter and use this carpark at your own risk.
3. Guests using this car park are required to deposit vehicle keys including access to security devices at reception.
4. We are not liable to you or any person with you for:
 - a. Injury to you or anyone else
 - b. Damage to, destruction of, theft of or unauthorised delivery of your vehicle.
 - c. Damage to, destruction of, theft of or unauthorised delivery of any property (including anything in or on your vehicle) however caused , and you release and indemnify us from any claim which you might have otherwise against us.
5. You agree to indemnify us in respect of any claim made against us in respect and any expenses incurred by us as a consequence of, in relation to, or in any way arising out of your use of this carpark.
6. If we deliver your vehicle to anyone in accordance with your instructions, we will not be liable to you even if the person taking the vehicle does not have your authority.
7. We have the right to retain your vehicle until we are provided with evidence that all incurred fees have been settled in full and evidence of proof of ownership.
8. If payment is not received in full, we may sell your vehicle after 30 days to recover money owing to us by you. In selling we may proceed in such manner as we think fit at our absolute discretion and we are not obliged to obtain the best price.
9. You agree to:
 - a. Produce proof of payment to us if requested.
 - b. Not cause any destruction
 - c. Not park in any designated no parking or reserved area,
 - d. Not to use this carpark other than in accordance with instructions we may give.
10. If you breach any of the conditions in item 7 above, you will be charged a compensation fee of \$100.00 AUD
11. While in this carpark you agree to comply with all signs and all reasonable directions and requests made by us, including the displaying of a parking voucher issued by the hotel receptionist.



- 12.** You may have access to or remove your vehicle from this carpark at any time, unless your vehicle has been valet parked and then access will only be permitted between 06:30am and 11:30pm. Guests wishing access to their vehicle outside these hours must make prior arrangements with the Hotel Duty Manager.
- 13.** We have the right to move or remove your vehicle at our discretion (including moving the vehicle outside this carpark), even if your vehicle is locked. We are not liable for any damage caused to your vehicle during the move or after the move.
- 14.** Any alteration to these conditions will be promulgated and compliance will continue under the altered conditions.
- 15.** Each exclusion of our liability to these conditions is subject to any State or Federal Law applicable in N.S.W. including the Trade Practices Act.
- 16.** In these conditions references to: us, we, or our refers to and means Airport Sydney International Inn, its employees, agents, and independent contractors and your vehicle includes any vehicle driven or intended to be driven by you into the carpark.
